CRS is a service enabling Deaf, hard of hearing, and speech disabled people who use telecommunication devices for the Deaf (TDD) to communicate over regular telephone lines with hearing people or people who do not use a TDD and vice versa. Individuals contact the relay service via the above 800 number. Specially trained California Relay operators complete all calls and stay on-line to relay messages either electronically over a TDD or verbally to hearing parties. The service is available for making telephone contacts 24 hours a day, 365 days a year, with no restrictions on the length, number or type of calls.
